Mr. Llewellyn-Taylor has again generously added to the Library's collection of incunabula with copies of Duranti's *Rationale divinatorum officiorum* (Venice, 1485) and Sidonius's *Epistolae et poemata* (Milan, 1498).

A group of Elzevirs and a number of interesting sixteenth and seventeenth century editions of the works of Erasmus, Melanchthon, Henri Estienne (the second), Drexelius, and Hugo de Groot are valuable additions to the already extensive list of scholarly antiquarian books which Mr. Llewellyn-Taylor has presented over many years.

Other works include twenty-five volumes of *The Historical Register* covering 1714-38, two finely-bound sets of five volumes each of Frances Burney's *Camilla* (1796) and *Cecilia* (1782) and her *Diary and Letters . . .* (1778-1840) edited in six volumes by Charlotte Barrett (London, 1904-5), Powel's *Historie of Cambria* (1584), and a well-preserved copy of the 1620 edition of the Welsh Bible.
